

SUBMISSION GUIDELINES-

- 1. An abstract of 250-300 words accompanied by details of the author containing his/her email ID, contact number and postal address should be sent. The full paper should be single-authored and between 3000-5000 words.
- 2. Mentioning the sub-theme is mandatory.
- 3. It must be typed in Times New Roman, font size 12 on A4 size paper with a 1.5" margin on all sides with 1.5-line spacing using MS Word.
- 4. ILI citation pattern must be strictly adhered to while submitting the abstracts and full paper.
- 5. Certificates will be awarded to everyone.
- 6. The papers presented in the seminar will be published as seminar proceedings in the form of a book.
- 7. One Best Paper Presenter Award will be given on the basis of the assessment of the resource persons.
