# \*About TNNLU\*

The Tamil Nadu National Law University (TNNLU) was established by the Government of Tamil Nadu by an Act of the State Legislature (Act No.9 of 2012) to provide quality legal education. The United Nations (UN) is an organization established in 1945 after the Second World War, the largest International Organization in the world with a current Membership of 193 States from across the globe. The primary functions of the UN are formulated based on the values, ideas, and principles geared towards international cooperation, harmony, and promote social welfare globally.

Article 1 of the UN Charter aims for UN to be a center for harmonizing actions of nations in the maintenance of international peace and security by developing friendly relations

among nations. In the 80 years since its inception, the UN has made numerous significant achievements. The UN has played a key role in global decolonization and the resolution of countless international conflicts, including the prevention of World Wars in multiple instances. Further, the UN has contributed towards peace and democratic governance in states such as Namibia and Cambodia by developing over 70 peacekeeping missions to support peace agreements and the protection of civilians.

## **\*** About the Conference **\***

The adoption of the Universal Declaration of Human Rights in 1948 by the UN led to the foundation of a global standard for Human Rights. The creation of treaties such as the International Covenant on Civil and Political Rights and the Convention on the Rights of the Child as well as the establishment of bodies and agencies such as the UN Human Rights Commission, World Food Programme (WFP), United Nations Children's Fund (UNICEF), to implement the international obligations. Various UN treaties has provided significant protections and upliftment to people across the world. Further, UN has led to the establishment of the UNCITRAL for resolving disputes and codification of the UNCLOS widely governing trade, development, and law of the

The UN also provides vital support to people during various crises ranging from natural disasters to wars to disease outbreaks. It has also put forth the Sustainable Development Goals (SDGs) to further its objective of achieving global prosperity in all walks of life by 2030. The UN and its agencies practically function and the areas it needs to address which require research and evaluation for the UN to be effective in promoting peace and prosperity for all ensuring mechanisms for dispute resolution at the international level. The complicated issues of international law, enforcement and disputes settlement process necessitates the interdisciplinary and multidisciplinary approach with how the UN framework operates.


Paper submissions and presentations on the above themes and sub-themes are invited. Joint authorship is permitted for up to two authors only.






