6. Themes

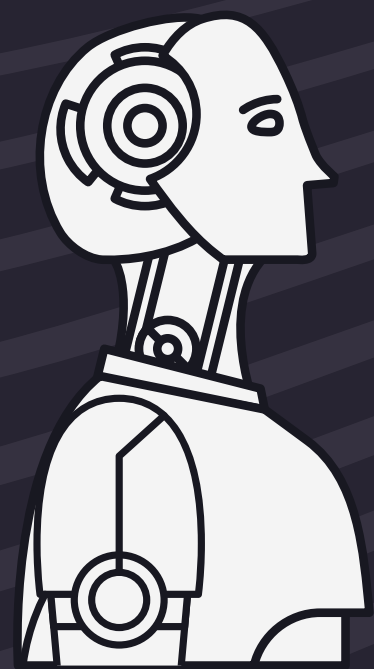
For this competition, participants are encouraged to explore these topics in depth and are not restricted to the specific wording or scope of the provided titles; they may develop their chosen topic further by including any relevant sub-topics they deem appropriate.

Topics

- Legal Accountability for AI-Driven Intellectual Property Infringements: An analysis of International and Indian Laws.

Or

- Effect of Jan Vishwas (Amendment of Provisions) Act, 2023: Decriminalization of IP Law



7. Format for Submission

The following format should be strictly followed by all competitors:

- The article should be an original work which has something new to say.
- Any AI generated content shall be immediately expelled.

- The length of the Article should not be more than 6-8 pages on an A4 size format.
- The submission should be in MS Word file type.
- No borders shall be applied.
- Reference and provide a citation of everything that is borrowed from another source. Use SCC and SCC Online citations in preference. Citation styles shall match those of standard law journals.
- Provide comprehensive reference of relevant legal sources & existing scholarship from India/South Asia and foreign and international courts where relevant.
- Cite primary sources, not an article from a blog/news source when relying on a judgement or statute.
- Use footnotes, not endnotes. Do not hyperlink to references.
- We reserve exclusive rights to publication. Give the editors four weeks after submission before checking the status of your submission.
- Font Size -12 (Body) and 14 (Headings)
- Font- Times New Roman

8. Registration & Submission

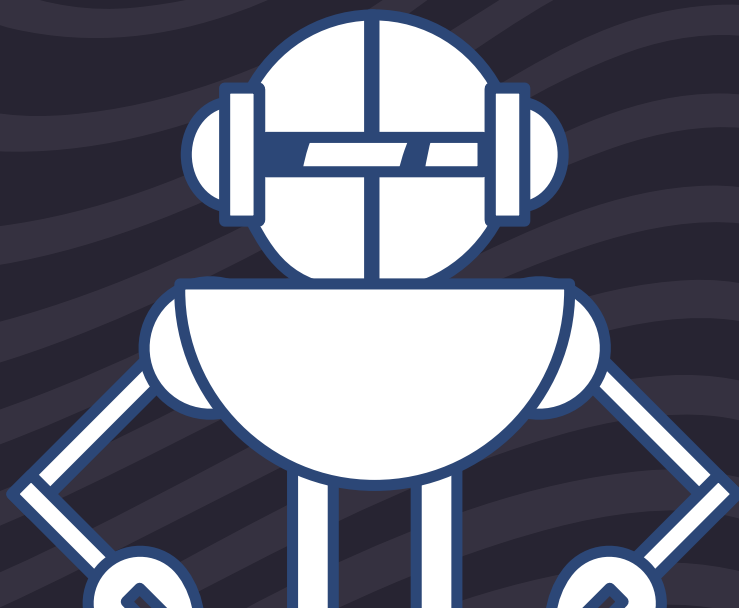
